Adopting a Rightshore® approach, Sogeti used a combination of onshore and offshore resources to carry out the testing, resulting in a reduction of 50% in test effort.

### The Client

### The Challenge

ING REIM had initiated an internal programme, VIRES, to improve the efficiency and reliability of the management information exchange between ING REIM, its administrative controllers and its clients. Before the new system could be piloted and launched, all new and modified software for data exchange and processing had to be thoroughly tested. ING REIM turned to Sogeti, an existing trusted provider of testing services.

## The Solution

Sogeti's solution was based on its Managed Testing Service. The service comprised of an onsite test manager in the Netherlands, supported by a team of Sogeti resources based offshore in India.

The test was prepared in India, based on the available test bases, together with the development of the necessary test scripts. Then a team in the Netherlands (made up of both Indian and Dutch resources) executed the tests at the client's location.

## The Benefits

The key results were that the new system was ready to be successfully launched, and that, through the Rightshore® combination of onshore and offshore sourcing, Sogeti achieved a 50% reduction in test effort, primarily through taking maximum advantage of the standardization of the tests.
